- The above dispensation will be applicable for **Special Spot/SSEA-IMS/Exclusive/Special Forward e-Auctions.**


**Sub: Extension of timeline for payment of coal value and

Various representations and proposals are being received from e-auction bidders/associations and coal companies respectively requesting for extension of timeline for payment/booking and lifting of coal under various e-auction schemes including Special Spot e-auction (SSEA-IMS) for importers.

In view of the above requests, the competent authority has accorded his approval for extending the following dispensation under ease of doing business as a general amnesty:

- In cases where the last date of deposition of coal value is falling in the month of March'21, date of payment/booking be extended to 30.04.2021. The lifting validity in such cases shall be as per guideline in vogue.
- The lifting period of the value paid orders which is maturing in March 2021 be extended till 30.04.2021.
- The above dispensation will be applicable for Special spot/SSEA-IMS/Exclusive/Special forward e-auctions.
- Subsidiary coal companies may extend such facility, wherever required, for materialization of coal allocated under e-auction schemes with due notification.
