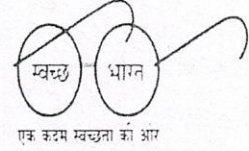




Dear All,

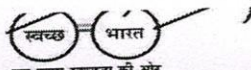

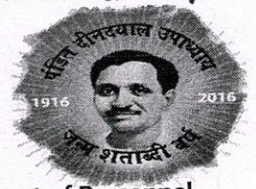
